# Frank Parker Memorial Beautification Award

In 1981, The Windsor Chamber of Commerce began a program to recognize those Windsor businesses that put forth a special effort to maintain a high standard of beautification of their property. In 1991, the Chamber renamed this award to honor Frank D. Parker, founding partner of Parker-Ellingwood Insurance Agency. Frank was a long time champion of Windsor businesses and the Windsor Chamber of Commerce. This award honors Mr. Parker's dedication to the community he lived in throughout his business life.

#### 2022 Recipient: Windsor Fire and EMS

For its renewal of the Windsor Fire and EMS Safety Complex.

Prior to the Windsor Police Department moving to their new location at 100 Addison Road, the Public Safety Complex at 340 Bloomfield Avenue consisted of the Windsor Center Fire Station, the Police Station and the separate EMS facility all on a 6.2 acre parcel. That facility was constructed in 1963.

Following the relocation of the Police Department in the summer of 2020, renovation of the Bloomfield Avenue facility began to upgrade the facility and address current and future equipment and personnel needs for both EMS and the volunteer fire department. The building was expanded from 27,000 square feet



to 38,400 square feet to accommodate additional and larger apparatus bays, improved parking, office and training space, kitchens and future sleeping/overnight quarters.

The new Fire and EMS Safety Complex features a modern stylistic exterior with traditional brick that conveys strength and continuity with many other Windsor buildings. It was dedicated on April 30, 2022 with gratitude to the residents of Windsor for supporting the project.



# Jerry Hallas Memorial Award

This award is presented in honor of Mr. J. Jeremiah Hallas, one of the group of forty Windsor business people who revitalized the Chamber in 1949. Mr. Hallas served as Chamber President in 1953-54. In addition to his Chamber work, Mr. Hallas founded the Windsor News Weekly in 1944. While living over thirty years in Windsor, Mr. Hallas served as Executive Assistant and Press Secretary to both Governor Wilbert Snow and Governor Raymond Baldwin. In 1947, he was appointed state political commentator for WTIC radio. He handled public relations in Connecticut for the 1952 Eisenhower campaign and the 1956 campaign for former U.S. Senator, Prescott Bush. We salute and thank Mr. Hallas for his outstanding contribution. The Windsor Chamber of Commerce expresses its appreciation for the dedication of our Jerry Hallas Memorial Award recipients and the service they have provided to the Chamber and the Town of Windsor.

#### 2022 Recipient: Mary-Lynn Kinney

Mary-Lynn Kinney is Senior Executive Vice President and Chief Operating Officer for Windsor Federal Savings whose responsibilities include managing and overseeing the day-to-day operations of the Association. Starting in August of 2000 as Vice President / Controller, she quickly was promoted in April 2003 to Vice President / Chief Financial Officer and again in July 2007 to EVP/CFO due to her extensive financial analysis, budgeting experience and over 25 years in the financial industry. She was again promoted to her current position in 2019.

Mary-Lynn has served as Treasurer of the Windsor Chamber of Commerce since 2007, and retires from the Board of Directors this summer after fifteen years as the Chamber's fiscal guardian. Her expert



and diligent attention to fiscal control and oversight has been a major factor in keeping the Chamber sound, stable, and secure. More than that, Mary-Lynn's equanimity and grounded but positive attitude as a leader, even through unstable and difficult times, have made an impact on the whole organization. Whenever and however the Chamber has needed her, Mary-Lynn has been there for us.

A Phi Beta Kappa graduate of the College of the Holy Cross and an honors graduate of the National School of Banking, she also held the position of Treasurer for the Huntington House Museum. Mary-Lynn and her family live in South Windsor, CT.



# Windsor Citizen of the Year

This is the 23rd year the Windsor Chamber of Commerce has presented the Citizen of the Year Award. This award is presented to a citizen who has provided outstanding service to our community.

### 2022 Recipients: Liz & Jim Burke

This year's Citizen of the Year Award is presented to a Windsor "power couple" who for decades have embodied the spirit of service to our community.

Liz Burke retired a year ago from a 48-year career as a Speech-Language Pathologist. When moving to Connecticut in 2000, she worked for Connecticut Children's Medical Center in their Hospital School and then the University of Connecticut for eleven years, where she had the pleasure of working with and training graduate students to become future Speech-Language Pathologists. Leaving UConn in 2015, she subsequently opened a private practice.

Liz has been a Board Member of the Windsor Education Foundation, ALP for adult learners and the Windsor Historical Society and has volunteered at the Historical Society for both school field trips and tours there. She has also volunteered as a tutor at the Wilson Branch Library, and with Jim, has



volunteered at the Windsor Arts Center. Last fall she worked on the Windsor Historical Society's Centennial events and is co-chairing its upcoming house tour.

Jim Burke recently retired as Windsor's Economic Development Director after 21 years of service to the community. During Jim's tenure, Windsor grew in importance as a regional employment center capitalizing on its strategic location between Hartford, CT and Springfield, MA as well as proximity to Bradley International Airport. Jim facilitated projects that created over 7,000 new jobs and resulted in approximately \$900 million in economic activity. Millions of square feet of additional office and industrial building space have been constructed in key industries including financial services, precision



manufacturing, logistics, data management and hospitality. These efforts have helped keep Windsor's tax rates competitive.

Jim was instrumental in the redevelopment of key properties in Windsor Center benefiting from the Hartford Line regional commuter rail service which began in 2018. These include a mill conversion into the 50-unit First Town Square condo project, as well as the Windsor Station Apartments containing 130 market-rate units directly across from the passenger rail station.

During his tenure, Jim led the town's Community Development efforts including the housing rehabilitation loan program, small business loan program and numerous infrastructure projects. He also served as staff liaison to the Human Relations Commission, Economic Development Commission, Wilson Deerfield Advisory Commission, Redevelopment Agency, and Fair Rent Commission.

Jim has also been a regular volunteer for projects with the Chamber of Commerce, First Town Downtown, Windsor Historical Society and Windsor Arts Center.

Liz and Jim live in the Town Center and have enjoyed many of the events on the town green and being part of such a wonderful, vital and active community. They have two sons and three grandchildren.
