Partners Will Educate Their Membership about the New Health Exchange

HARTFORD, CT, June 5, 2013—Access Health CT is pleased to announced that they have engaged the Connecticut Chamber of Commerce Leadership Cabinet along with the Chamber Insurance Trust to help educate their membership about the new health insurance exchange launching in October of this year.

This partnership will look to ensure that the new benefits available to small businesses under the Affordable Care Act reach the Chambers' broad membership base, and allow them opportunities and forums to evaluate coverage options and enroll. Access Health CT is one of the few state exchanges to launch Small Employer Health Options Plans (SHOP), which will offer a variety of health insurance options to small businesses and their employees. SHOP will enable small employers to offer plans from multiple insurers to their employees and receive a single bill.

Access Health CT will actively work with insurance brokers across the state to ensure they are trained and supported as they work with the Chamber's members as well as other interested small businesses.

Chamber member brokers are being trained in all aspects of the new marketplace as it relates to Small Business Tax Credits, to Individual Subsidies, to enrolling in SHOP.

Its mission is to increase the number of insured residents in Connecticut, promote health, lower costs and eliminate health disparities. Its vision is to provide a simple online shopping and enrollment experience for state residents and small businesses, starting with open enrollment in October 2013.

Access Health CT will ensure that participating health plans meet certain standards, and will facilitate competition and choice by rating the quality of each plan. Individuals and families buying coverage through the Exchange may qualify for tax credits on premiums.
